



TERMS AND CONDITIONS FOR OPEN ENROLLMENT PROGRAMS AT WEST POINT

The open enrollment program for which you are registering, which includes in-person, virtual and online sessions (the “Program”) is owned by Thayer Leader Development Group, Inc. (“Thayer”), 674 Thayer Road, West Point, New York 10996. The online sessions of the Program are hosted by Udemy, Inc. (“Udemy”), which provides the system platform for the online portion of the Program. The virtual sessions of the Program may be hosted by Zoom, Microsoft Teams or another virtual system platform.

Your registration and participation in the Program are governed by the provisions contained in these Terms and Conditions (the “Terms and Conditions”). Because you are registering online, your consent to these Terms and Conditions is indicated by checking the box beside “I agree to the Terms and Conditions” on the registration link and your consent to Thayer’s collection of your personal data is indicated by checking the box beside “I agree to the Privacy Policy” on the registration link. **IF YOU DO NOT AGREE TO THESE TERMS AND CONDITIONS YOU MAY NOT ACCESS, PARTICIPATE IN OR OTHERWISE USE ANY PORTION OF THE COURSE.**

As used in these Terms and Conditions, “you” may mean you as an individual participant in the Program. You may be participating on behalf of an employer or corporate sponsor that has signed a separate client services agreement with Thayer (the “Client Services Agreement”), and/or paid for your registration in the Program. If so, your registration is governed by these Terms and Conditions, as well as by that Client Services Agreement (to the extent applicable). In the event of a conflict between these Terms and Conditions and the Client Services Agreement, the applicable Client Services Agreement shall prevail.

Use of the Program

The content provided in the Program is for your personal development purposes only. You may access and participate in the Program solely pursuant to these Terms and Conditions for your personal or professional, non-commercial use. By registering for the Program, you represent and warrant that all information you submit is truthful and accurate, and you are 18 years of age or older.

Payment

Your registration payment includes the cost of all Thayer services and deliverables, as well as the cost of hotel accommodation, conference services and meals on the specific dates and times of the in-person program events, as specified on your applicable registration web page. Your payment does not include mini-bar charges, long-distance or phone charges or additional services not otherwise specified, nor does it include the cost of participants other than yourself. You are responsible for providing your own transportation to and from The Historic Thayer Hotel at West Point. While hotel accommodation is generally provided at the Historic Thayer Hotel at West Point, you agree to stay at an alternative location nearby without refund or additional charge if the Historic Thayer Hotel determines a need to change room bookings.

The Program registration fee provides you with the right to attend the in-person sessions of the Program, as well as a license for one participant to access the online and virtual sessions of Program. The full Program fee is due upon registration. Your registration submission will be reviewed for acceptance once your registration information and full payment are both received. Thayer will accept credit card payments through its website registration, over the phone or in person. Registration closes two weeks prior to the start date of the Program. Registration for the Program is limited only to you and is on a first-come, first-serve basis. Spaces are only guaranteed once the registration is approved and full payment has been received. You will receive a registration and payment confirmation email separately upon receipt and verification, respectively.

Cancellation

In preparation for the Program, we initiate many administrative and logistical actions related to your registration which incur a variety of costs prior to the launch. Therefore, the following fees apply, based on the amount of advance notice you provide to us:

*Phase 1 – this refers to the first day of the online pre-work program provided by Thayer.

Substitutions: Substitution requests (i.e., to substitute your registration in this Program to a different participant) must be submitted at least 3 days before Phase 1 of the Program begins. To be considered a completed substitution request, the request must be made in writing and include all required participant registration information for the new participant. Otherwise, the appropriate Transfer Fee or Cancellation Fee policy will be applied.

Transfers: Transfer requests (i.e., to transfer your registration in this Program to a different Thayer open enrollment program) must be made in writing and indicate the new date or new program you wish to attend. Otherwise, the appropriate Cancellation Fee policy will be applied. Your pre-paid registration payment and any balance owed will be applied to the new program; provided that you will be required to pay Thayer the difference if the new program fee is higher. Tuition will become 100% non-refundable if you transfer more than 2 times or do not attend another program within 12 months of the original program start date. Transfers to the requested new program are not guaranteed as space may not be available.

Cancellations: If requested, any remaining balance of a cancelled Program's payment can be applied to another Thayer program within 12 months of the original Program's Phase 1 date. After 12 months, the balance is non-refundable.

If Thayer cancels the Program due to an act of God or any other condition reasonably beyond Thayer's control that makes it impossible or unreasonable to hold the Program, Thayer shall not provide any refunds or credits; provided, however, that Thayer shall make reasonable efforts to transfer your payment and registration to another similar program.

Thayer may decide to convert an outdoor experiential program into a comparable indoor experiential program due to weather conditions, without any liability or refund owing to any participant.

System Requirements

To access the online and virtual portions of the Program, you will need a computer or mobile device with the system requirements, hardware and operating systems outlined on the registration link, as well as internet access. Please check that your computer or device has the necessary requirements to access the Program, prior to registration. If your computer or device does not have these requirements, you will not be able to access the Program and your fee will not be refunded.

Privacy

Thayer takes your privacy seriously. Please note, however, that certain information you provide during the Program may be available to other Program participants. In addition to using your personal data to provide services to you, your consent permits Thayer to use your personal data: (i) provide more customized facilitation of the Program, (ii) validate your completion of the Program and facilitate the production of a digital completion certificate to be generated, processed and issued by Thayer's sub-contracted vendor, EdInvent, Inc. dba Accredible ("Accredible"), and (iii) provide feedback to Thayer on how to improve the Program.

You agree that upon completion of the Program, you consent to Thayer retaining your name, contact information and a record of having taken the Program for the exclusive purpose of Thayer contacting you with future information to sustain your learning, to inform you about upcoming Thayer events or programs, and/or to verify your participation in the Program. Thayer may also share your name, title, contact information, program name, and dates you attended the Program, along with any other necessary information, with the Subcontractors listed below, as necessary to deliver the Services. Unauthorized Use

You agree not to use the Program for illegal purposes. As a participant, you may not use this Program for any commercial purpose, other than to improve your own executive management and leadership skills at work. You may not screenshot or use automated data mining techniques to catalog, download, store or otherwise reproduce, store or distribute any written content provided pursuant to the Program. You may not take any action to damage or interfere with the Program or any other user's participation in or access to the Program, including, without limitation, via means of overloading, "flooding", "mailbombing" or "crashing" the system platform. You may not send unsolicited e-mail, including promotions and/or advertising of products or services, through the Program or forge or mask your true identity in any e-mail or posting. Restrictions

You agree not to: (a) share password access with other individuals for which a license has not been purchased; (b) distribute, share, sublicense, lend, lease or otherwise make the Program, written Program materials or the system platform available to any third party (on the Internet, an information network or tangible media, by broadcast or in any other manner); (c) modify, adapt, create derivative works from or translate any part of the Program, written Program content, or system platform; (d) reverse engineer, decompile or disassemble the course or the system platform or otherwise attempt to obtain its source code; or (e) remove or alter any copyright, trademark or other proprietary notice contained in the Program materials or system platform. Grant of License and Ownership of Intellectual Property

Upon your payment in full of the Program fee, submission of registration information, agreement to these Terms and Conditions and Thayer's acceptance of your registration application, Thayer grants you a revocable, non-exclusive, limited license to participate in the Program in accordance with these Terms and Conditions. Each grant of license to the Program is unique to you and any access to the Program may not be shared with any other person via shared login access or any other method. Neither the Program nor Udemy's system platform, nor any portion thereof, may be resold or redistributed or otherwise distributed in any manner. Intellectual property rights in the Program curriculum, designs, ideas and materials developed by Thayer and/or Thayer instructors shall vest exclusively in Thayer and/or the Thayer instructors, who shall have sole and exclusive ownership of the intellectual property rights therein (as applicable). Thayer uses this information solely to provide this to the West Point Visitor's Center to facilitate your entrance onto the premises for the in-person portion of the Program. To the extent that you provide medical information to us, we will use this only to provide necessary accommodations in delivering services to you. handle your personal data. Once accepted, you will still need to have your personal government-issued ID on hand to enter West Point. Access to all in-person Services at West Point is not guaranteed. If West Point Visitor's Center denies access, you may not be able to attend certain in-person sessions, and no refund or credit shall be issued in connection with such denial.

There may be reasons why Thayer is unable to facilitate your advance approval to access West Point (i.e., you are part of a group of 25 or fewer participants, or your information was not submitted correctly, completely, or in time). In such case, you may be required to report in person to the West Point Visitor Control Center (VCC) upon arrival or during the designated time on your agenda to complete the visitor screening process and obtain a Local Area Credential pass. Please allow extra time for this process, as it can take up to over an hour. Further information on this process will be provided to you, along with instructions if you are not a US citizen. To avoid any delays during the screening process, all participants should review the requirements and bring the appropriate documentation with them to West Point.

Indemnity

You understand and agree that you are personally responsible for your behavior while participating in the Program.
